## DECISION

Pursuant to Article 104 of the Law of 14 June 1960 – Code of Administrative Procedure (consolidated text: Journal of Laws of 2018 item 2096, as amended), in conjunction with Article 9a(1) and (3) of the Act of 13 October 1995 Hunting Law (consolidated text: Journal of Laws of 2020, item 67) and section 1(1)(2o, s, x) of the Regulation of the Minister of the Environment of 11 March 2005 on establishing the list of game species (Journal of Laws of 2005, No. 45, items 433 and 434), having examined the application of 14.01.2020, ref.: POPDOW-ZPT.073.2.2020 submitted by Krystyna Araszkievicz, Sweco Consulting Sp. z o.o., ul. Łyskowskiego 16, 71-641 Szczecin, acting under the power of attorney of State Water Management Polish Waters The Regional Water Management Authority in Szczecin, ul. Tama Pomorzańska 13 A 70 - 030 Szczecin, taking into account the opinion of 04.02.2020, ref.: L.dz.107/A/WHKLiS/2020 issued by the Polish Hunting Association in Warsaw,

### I hereby allow

Krystyna Araszkievicz, Sweco Consulting Sp. z o.o., ul. Łyskowskiego 16, 71-641 Szczecin, acting under the power of attorney of State Water Management Polish Waters The Regional Water Management Authority in Szczecin, ul. Tama Pomorzańska 13 A, 70 - 030 Szczecin to perform the action of game disturbance for the following species: mallard (*Anas platyrhynchos*), greylag goose (*Anser anser*), wood pigeon (*Columba palumbus*) in connection with the intention to implement the planned project involving the reconstruction of bridges to ensure minimum clearance, applying to the demolition of the existing bridge and the construction of a new road bridge at 107 + 211 km of national road no. 31 in Kostrzyn nad Odrą, reconstruction of the road bridge at 2 + 450 km of the river Warta in Kostrzyn nad Odrą to ensure minimum clearance for icebreaking operations with the use of icebreakers, execution of accompanying works involving the expansion of national road no. 31 (ul. Sikorskiego) at the points of access to the bridge, execution of the necessary reconstruction of water supply and other systems.

1. The game disturbance actions will take place on the following registered plots:

- a) 62; 64; 2/1; 2/3 - locality 0006 Stare Miasto, the commune of Kostrzyn nad Odrą, Gorzów district, Lubuskie province.
- b) 394/57; 346/11; 345/3; 345/1; 345/2; 344; 268/2; 347; 348/1; 349; 350; 394/36; 394/39; 394/40; 394/42; - locality 0004 Śródmieście Kostrzyn nad Odrą Gorzów district, Lubuskie province.

- c) 2/1; 2/3 - locality 0006 Stare Miasto, the commune of Kostrzyn nad Odrą, Gorzów district, Lubuskie province.
2. The investor or the investor's representative shall notify the issuing authority of the date of investment commencement in writing, no later than 14 days before the investment starts.
  3. In the course of investment implementation, disturbance will take place due to the presence of people participating in the investment process and noise: movement of heavy equipment and machinery, operation of equipment directly related to the conducted works.
  4. In the event of any damage caused as a result of game disturbance, the injured party may file claims against the investor in the course of civil law proceedings including referring the case to court through a competent common court.
  5. To assess the implementation conditions resulting from the need to protect populations of game species and their habitats, possible negative impact or minimisation of the impact of investment on game species, creating conditions for the safe existence of game:
    - 5.1 in the area of investment implementation (Article 9a (3)(4) of the Hunting Law), supervision over the disturbance of game is entrusted to the mayor of Kostrzyn nad Odrą.
    - 5.2 the investor will appoint an environmental supervision team who will assess game habitats before the investment begins and after its completion, and, additionally, if there is a necessity to perform assessment at the request of the person issuing the permit on the basis of control activities.
  6. The following persons will be authorized to carry out checks of the issued permit in the field:
    - 6.1 Mayor of Kostrzyn nad Odrą
    - 6.2 authorized employees of the office of the Lubuskie Province Marshal.
  7. The recipient of the permit is obliged to immediately notify the issuing authority in the event of its early use.
  8. The permit holder will submit a report to the permit issuer within 30 days of its use.
  9. In order to ensure the correct use of the permit for a derogation from the ban on disturbing game, the Marshal of the Lubuskie Province checks whether the conditions set out in the permit issued are complied with and in the event of non-compliance, revokes the permit (Article 9 a (4) in connection with Article 44 (12) of the Hunting Law).
  9. **The permit is valid from the effective date to 31 May 2023.**

### **Justification**

Krystyna Araszkiwicz, Sweco Consulting Sp. z o.o., ul. Łyskowskiego 16, 71-641 Szczecin, acting under the power of attorney of State Water Management Polish Waters The Regional Water Management Authority in Szczecin, ul. Tama Pomorzańska 13 A 70 - 030 Szczecin, with the application of 14 January 2020 ref.: POPDOW-ZPT. 073.2.2020 requested permission from the Marshal of the Lubuskie province for

a derogation from the ban on disturbing game of the species: mallard (*Anas platyrhynchos*), greylag goose (*Anser anser*), wood pigeon (*Columba palumbus*) in connection with the planned implementation of the project involving the reconstruction of bridges to ensure minimum clearance, and concerns the demolition of the existing bridge and the construction of a new road bridge at 107 + 211 km of national road no. 31 in Kostrzyn nad Odrą, reconstruction of the road bridge at 2 + 450 km of the river Warta in Kostrzyn nad Odrą to ensure minimum clearance for icebreaking operations with the use of icebreakers, execution of accompanying works involving the expansion of national road no. 31 (ul. Sikorskiego) at the points of access to the bridge, execution of the necessary reconstruction of water supply and other systems.

The game disturbance actions would take place on the following registered plots:

- a) 62; 64; 2/1; 2/3 - locality 0006 Stare Miasto, the commune of Kostrzyn nad Odrą, Gorzów district, Lubuskie province.
- b) 394/57; 346/11; 345/3; 345/1; 345/2; 344; 268/2; 347; 348/1; 349; 350; 394/36; 394/39; 394/40; 394/42; - locality 0004 Śródmieście Kostrzyn nad Odrą, Gorzów district, Lubuskie province.
- c) 2/1; 2/3 - locality 0006 Stare Miasto, the commune of Kostrzyn nad Odrą Gorzów district, Lubuskie province.

The following documents were attached to the application:

1. A topographic map with the investment location marked.
2. Confirmation of payment of stamp duty for issuing the permit and power of attorney in the matter.
3. Notary certification Power of Attorney of 28.05.2019, ref.: SZ.R00.012.98.2019.MG.

In accordance with art. 9a (1) of the Hunting Law, having consulted the Polish Hunting Association, the marshal of the province may allow a derogation from the ban on game disturbance. The permit may be issued in the absence of alternative solutions and if it is not detrimental to the conservation of wild game populations. Pursuant to section 1(1)(2 o, s, x) of the Regulation of the Minister of the Environment of 11 March 2005 on establishing the list of game species (Journal of Laws of 2005, No. 45, items 433 and 434): the mallard (*Anas platyrhynchos*), greylag goose (*Anser anser*), wood pigeon (*Columba palumbus*) are game species.

By the letter of 20.01.2020, ref.: DW.1.7131.2.2020, pursuant to section 86(12) of the Statute of the Polish Hunting Association constituting an Attachment to the resolution of the XXIV National Convention of PHA Delegates of 16 February 2019, pursuant to the provisions of Art. 9a(1) of the Hunting Law,

the Management Board of the Polish Hunting Association in Warsaw was asked for an opinion on the matter. By the letter of 04.02.2020, ref.: Ldz. 107/A/WHKLiS/2020 The Polish Hunting Association in Warsaw gave a positive opinion regarding the issue of the permit in question, while also declaring that no game animals would suffer as a result of the undertaken actions and there is no alternative to carrying out the project activities. The director of the Regional Directorate of State Forests in Szczecin, the mayor of Kostrzyn nad Odrą, the Dębno Forest Inspectorate manager, and the chairman of the District Board of the Polish Hunting Association in Gorzów Wlkp. did not raise any objections or reservations in this matter.

In view of the above, taking into account the analyses carried out, issuing a permit for a derogation from the ban on disturbing the abovementioned game animals in connection with project implementation is fully justified.

### **Instruction**

Parties may appeal against the permit to the Self-government Appeals Court in Zielona Góra through my office, within 14 days of the date of permit receipt.

Pursuant to Article 127a of the Code of Administrative Procedure, I inform you that a party may waive the right to appeal against the authority that issued the decision, and that the decision shall become final and binding on the date the authority receives the statement of waiver of the right to appeal from the last of the Parties to the proceedings.

based on Article 113 § 1 of the Code of Administrative Procedure (Journal of Laws of 2018, item 2096, as amended), in connection with Article 9a paragraph 3 point 1 of the Hunting Law Act of 13 October 1995 (Journal of Laws of 2020, item 67) on the permit to disturb game

**decides:**

**to correct a mistake in the decision of the Marshal of the Lubuskie Province of 24 February 2020, ref. no.: DW.1.7131.2.2020 on the permit to perform the action of game disturbance for the species: mallard (*Anas platyrhynchos*), greylag goose (*Anser anser*), wood pigeon (*Columba palumbus*) in connection with the planned implementation of the project involving the reconstruction of bridges to ensure minimum clearance, and concerns the demolition of the existing bridge and the construction of a new road bridge at 107 + 211 km of national road no. 31 in Kostrzyn nad Odrą, reconstruction of the road bridge at 2 + 450 km of the river Warta in Kostrzyn nad Odrą to ensure minimum clearance for icebreaking operations with the use of icebreakers, execution of accompanying works involving the expansion of national road no. 31 (ul. ## Justification

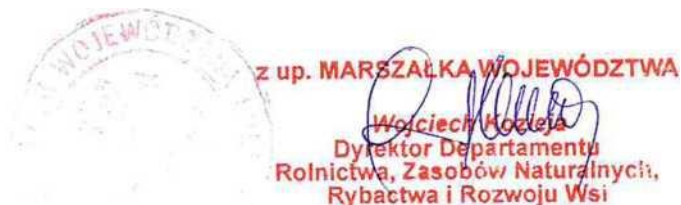
With the decision of 24 February 2020, ref. no.: DW.1.7131.2.2020, the Marshal of the Lubuskie Province gave his permission for the action of game disturbance for the species: mallard (*Anas platyrhynchos*), greylag goose (*Anser anser*), wood pigeon (*Columba palumbus*), in connection with the intention to implement the planned

project involving the reconstruction of bridges to ensure minimal clearance and concerns the demolition of the existing bridge and the construction of a new road bridge at 107 + 211 km of national road no. 31 in Kostrzyn nad Odrą, reconstruction of the road bridge at 2 + 450 km of the river Warta in Kostrzyn nad Odrą to ensure minimum clearance for icebreaking operations with the use of icebreakers, execution of accompanying works involving the expansion of national road no. 31 (ul. Sikorskiego) at the points of access to the bridge, execution of the necessary reconstruction of water supply and other systems.
